# NARA FIGHT CONTRACT

This Professional Boxing Bout Agreement ("Agreement") is entered into on this **21st day of March 2025** by and between:

1. **Promoter: Nara Promotionz**
2. **Boxer 1: Ayub Mwankina** – A licensed professional boxer with license number \_\_\_\_\_, issued by \_\_\_\_\_
3. **Boxer 2: Farahat Manirola** – A licensed professional boxer with license number \_\_\_\_\_, issued by **UBF**

The parties agree to the following terms and conditions:

## 1. Bout Details

- **Event:** Professional Boxing Bout
- **Date:** 26th April 2025
- **Weigh-in Date:** 25th April 2025
- **Venue:** Club Obligato, Kampala, Uganda
- **Weight Class:** Super Lightweight (Maximum 63.5 kg / 140 lbs)
- **Rounds:** 8
- **Round Duration:** 3 minutes each with a 1-minute rest interval
- **Sanctioning Body:** Uganda Boxing Federation (UBF)

## 2. Boxer Purse and Payment Terms

- Each boxer shall receive a purse of **\$700 USD (Seven Hundred Dollars)**.
- Payments shall be made Using **Cash** or any other agreed-upon payment method.



- Both boxers must weigh no more than **63.5 kg (140 lbs)** at the official weigh-in on **25th April 2025**.
  - Failure to meet the required weight will result in a **\$100 USD** deduction from the boxer's purse.

## 4. Medical Requirements

- Each boxer shall submit the following valid medical reports no later than **30 days** before the bout:
    - **Hepatitis B & C Test Results**
    - **HIV/AIDS Test Results**
    - **General Medical Examination Clearance**
  - The sanctioning body (**UBF**) will confirm the boxers' fitness to compete.
- 

## 5. Promotional Obligations

- Both boxers agree to participate in all promotional activities organized by **Nara Promotionz**, including:
    - Press Conferences
    - Weigh-in Ceremonies
    - Public Training Sessions
    - Media Interviews
  - Failure to attend promotional events without valid justification will result in a penalty deduction of **\$50 USD**.
- 

## 6. Time Management and Penalties

- Boxers must report on time for all official events (e.g., weigh-ins, press conferences, and fight-related activities).
  - Any boxer who fails to appear on time will face a penalty deduction of **\$100 USD**.
  - Boxers who sign another fight contract before fulfilling this agreement will face disciplinary actions and fines determined by **UBF**.

## 7. Conduct and Disciplinary Measures

- Both boxers shall maintain a professional demeanor at all times.
  - Any form of misconduct, unsportsmanlike behavior, or intentional harm outside the ring will lead to disciplinary measures, including fines or suspension.
- 

## 8. Governing Law and Dispute Resolution

- This agreement is governed by the laws of the **Republic of Uganda**.
  - Any disputes arising from this contract shall be resolved by arbitration under the regulations of the **Uganda Boxing Federation (UBF)**.
